## CAS Standards for Collegiate Recreation Reviewer Criteria:

1. Mix of experts from small, medium and large programs
2. Mix of academic, athletic, business and student affairs based programs
3. Demonstrated involvement in and commitment to the profession through participation in NIRSA
4. Significant experience (10 years) in the profession both in programming and facility operations
5. Knowledge and understanding of and experience with the current CAS standards for Recreational Sports and other associated standards of practice
6. Demonstrated commitment to the use of CAS standards as a tool to guide quality practice
7. Requisite knowledge, skills, and attitudes associated with the evolving field of recreation
8. Willingness to engage in the extensive CAS review process (6 -9 months)
9. Membership as Registered Collegiate Recreational Sports Professional (RCRSP) preferred but not required.
10. Experience on a non-recreational sports CAS self-assessment review team, preferred but not required

## **The expectations of a member of the CAS Standards Review Task Force include:**

- **Serve a three-year term on the CAS Standards Review Task Force , beginning June 1, 2015**
- **Maintain professional NIRSA Membership during the entire appointment to the Task Force**
- **Review assigned standards within the allocated time period**
