Considerations when designing your legacy:

- A gift of \$28,000, and NIRSA Foundation Board of Directors approval, is necessary to establish a named endowment.
- Individual gifts of \$5,000 or greater may be named by the Donor, subject to approval from the NIRSA Foundation Board of Directors.
- The NIRSA Foundation will determine the timing and amount of the expenditures.
- The Executive Director is responsible for ensuring that the gift is used for a purpose in most alignment with the Donor's original intention.
- The NIRSA Foundation is unable to accept:
 - Gifts of real or personal property.
 - Any gifts that violate federal, state, or local law, statute, or ordinance
 - Any gifts that contain unreasonable conditions or partial interest in property
 - Any gifts that are made with conditions that state the proceeds will be spent by NIRSA Foundation for the personal benefit of a named individual.
 - Any gifts that could expose the NIRSA Foundation to liability.
